PAY GAP IN SWITZERLAND

On average, women earn CHF 1455 less per month than men. 56 % of this amount can be explained by objective factors such as professional The federal government has made the Logib position, years of service or educational level. standard analysis tool available free of charge to 44% of the pay gap remains unexplained and all companies wishing to carry out an equal pay equates to lost income of CHF 642 a month.

THE GENDER EQUALITY ACT

The Gender Equality Act now requires employers with 100 or more employees to conduct an equal pay analysis, have it verified by an independent body and inform the employees of the result. The aim is to enforce the constitutional right to equal pay for work of equal value.


